What is this product?

Type

This product is a UCITS Fund. The Fund is a sub-fund of GenFunds Global Plc, an open-ended investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between funds. The Fund's assets are held through its Depository, which is European Depository Bank SA, Dublin Branch. This is an investment fund primarily investing in European equity and equity-related securities which has considerable latitude over its asset allocation.

Investors may not get back all the money invested and an investment in this Fund should only form part of an investor's total portfolio. Investors should discuss the suitability of this Fund with their professional adviser.

Term

This Fund is open-ended and has an indefinite duration. The Fund may be terminated at any time in line with the constitutional documents of the Company.

Requests to buy, exchange or sell Fund shares that are received and accepted by the administrator by 3:00 PM CET (2:00 PM UK time) on any Fund business day are ordinarily processed the same day using valuations of that day. Settlement of Redemption requests typically occurs within 5 business days after a request has been accepted. Further details on the conditions associated with the Redemption of shares is included under the section "How long should I hold it and can I take money out early?"

At any time the Company may by giving not less than four nor more than twelve weeks' notice (expiring on a Dealing Day) to all Shareholders in the Company or in any Sub-Fund or Class, redeem at the Redemption Price on such Dealing Day, all (but not some) of the Shares in the Company or in the relevant Sub-Fund or Class not previously redeemed.

The Company may at any time redeem or request the transfer of Shares held by Shareholders who are excluded from purchasing or holding Shares under the Articles.

Any such redemption will be made on a Dealing Day at the Redemption Price on the relevant Dealing Day on which the Shares are to be redeemed.

Objectives

The investment objective of this Fund is to generate long term capital growth for investors, primarily by investing long in European equities.

The Fund primarily aims to gain investment exposure to European equities. The Fund aims to achieve its objective by investing long (seeking to profit from an increase in the price of a security).

The Fund may also invest up to 10% of its net asset value in debt securities which may include government and corporate bonds and notes (fixed and floating rate) and commercial paper which may be rated either above or below investment grade (a rating of BBB or above by Standards & Poor's or another internationally recognised credit agency).

The Fund may also invest in securities with equity characteristics issued by companies in the European Union and the United Kingdom.

Derivatives (instruments whose value depends on the rise and fall of other assets) may be used to achieve the investment objective and reduce risk or manage the Fund more effectively. Derivatives being invested in may include: swaps (including equity, interest rate, currency, credit default, index, total return swaps or swaptions), options, futures, foreign exchange contracts, convertible bonds and warrants. The type of instruments and a description of the purpose for which they may be used is set out in Appendix IV of the Prospectus. Short positions may only be achieved through the use of derivatives.

The Fund may also invest in ancillary liquid assets and may retain amounts in cash or cash equivalents if considered appropriate to the investment objective or for defensive purposes.

The Fund is actively managed and not constrained by any benchmark index. However, the MSCI Europe TR EUR Index is used solely for the purposes of comparing the performance of the Fund. The Fund may utilise techniques and instruments, such as futures, options, swaps, repurchase and reverse repurchase agreements, stocklending arrangements and forward currency contracts, for efficient portfolio management in order to reduce risk and/or costs and/or to generate additional income for the Fund.

Any income less expenses earned by the Fund will not be distributed to investors but will be retained within the assets of the Fund.

Intended retail investor

This product is intended for investors seeking long term capital growth and typical equity market volatility and risk in the management of their assets. It is designed to form part of a portfolio of investments. What are the risks and what could I get in return?

Risk Indicator

What are the costs?

How long should I hold it and can I take money out early?

Order Schedule:

Settlement of Redemption requests typically occurs within 5 business days after a request has been accepted.

If the number of Shares in a Sub-Fund falling to be redeemed on any Dealing Day exceed ten per cent or more of the total number of Shares in issue or deemed to be in issue in that Sub-Fund on such Dealing Day or exceed ten per cent of the Net Asset Value of that Sub-Fund, then the Directors may in their absolute discretion refuse to redeem any Shares in excess of ten per cent of the total number of Shares in that Sub-Fund in issue or deemed to be in issue or in excess of ten per cent of the Net Asset Value as aforesaid and, if they so refuse, the requests for redemption on such Dealing Day shall be reduced rateably and the Shares to which each request relates which are not redeemed by reason of such refusal shall be treated as if a request for redemption had been made in respect of each subsequent Dealing Day until all the Shares to which the original request related have been redeemed

How can I complain?

As an investor in the Fund, you are entitled to make a complaint free of charge. Any complaint must be handled by the Management Company promptly and effectively.
